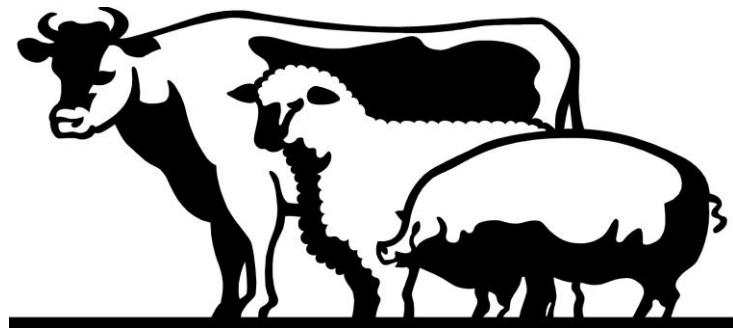
Henry County Fair Camping Rules

1. Campers will be assigned campsites on a first come, first serve basis. Reservations and prepaid spots are considered: First Come – First Serve. So, get reservations in early to reserve a spot.
2. Total payment is due upon arrival *and* permits are to be picked up *before* parking camping unit.
3. The campgrounds are located on the “West Hill” of the fairgrounds.
4. Tent Camping does *not* include electricity or water.
5. Only one vehicle per campsite. All other vehicles should be parked in designated areas.
6. Camping Permit is to be placed in a visible location on camping unit.
7. All camping units must be in place by 6:00pm the first day and vacate their spots by 5:00pm the last day, or an additional day of camping will be charged.
8. Quiet hours are from 11:00pm to 8:00am
9. All camping units will enter through the “Northeast” Gate of the fairgrounds.
10. All pets must have current vaccinations and have proof of such vaccinations upon request of a Henry County Fair employee or director. All pets must be on a leash or chain. *Clean up after your pets!!!*
11. No pets allowed in grandstand or in the infield area, unless they are service animals.
12. All jacks or jack stands must have footpads.
13. There are showers available in the public bathrooms located on the North side of grounds by the livestock barns. Please respect the restrooms and be cleanly.
14. We ask that all trash be placed in trash barrels located throughout the campground.
15. Absolutely no vehicle or camping unit washing allowed on grounds.
16. It is unlawful by Illinois State Law for a child sex offender to knowingly operate, manage, be employed by, or be associated with any county fair when persons under the age of 18 are present.
17. No open campfires allowed.
18. The Camping Director reserves the right to evict any individual or group for breaking any of these, or the Henry County Fair Rules. No Refunds Will Be Paid To Violators!!
