Rule 2 If the same animals are shown in both the junior and open shows, they must be shown under the same exhibitor name in each of the shows.

Rules and Regulations:

Rule 1 Weigh-in begins Monday, June 18, 2018, starting after help weigh in. to noon and 1 to 4 p.m. No pigs may arrive on the fairgrounds before 6 a.m., Monday, June 18, 2018. Swine may leave the fairgrounds after the Open Show or Jr. Show. All other hogs must be removed from the fairgrounds by 10 a.m. Friday, June 22, 2018. Weights will be 150 - 300 lbs. for gilts and/or barrows. Pigs disqualified for weight may be substituted.

Rule 2 Entries allowed per exhibitor - six single barrows.

Rule 3 When coming to the fair, all swine should enter the northeast gate of the fairgrounds. Health certificates must accompany all swine, may be inspected. **Health papers must be turned in to the Fair Office at weigh-in.**

Rule 4 1. Any boy or girl, who during the year has conducted a supervised 4-H or FFA program, with records kept therein, may enter the Junior Livestock Division. A minimum age of 8 as SEPTEMBER 1, 2017 is required to participate in the State Fair Junior Livestock Division.

2. Programs may be done under the supervision of:

A. 4-H leaders or Extension staff members

B. Teachers of Vocational Agriculture

3. Illinois 4-H members exhibiting in the Junior Livestock Division of the Illinois State Fair must be active 4-H club members, as verified by the County Extension Office and at least 8 but not yet 18 years of age on September 1, 2017. Active Illinois FFA members, as verified by local Teachers of Vocational Agriculture, may participate.

4. Individuals previously enrolled in Illinois 4-H or FFA programs and under 21 years of age as of September 1, 2017, may participate in the Junior Livestock Division of the Illinois State Fair provided they are active FFA members as verified by Illinois FFA and in accordance with one of the following options:

A. Maintain active membership on the roster of their local high school FFA Chapter;

B. Maintain active membership in a collegiate FFA Chapter in a post-secondary institution of higher education in the State of Illinois; or

C. Maintain active membership in an Illinois FFA Alumni Chapter. FFA members must not have reached their 21st birthday as of September 2017.

Rule 5 Only junior exhibitors will be allowed to show. Any and all conflicts must be cleared through the swine superintendent. All animals must be owned by the exhibitor.

Rule 6 Barrows, market gilts and breeding gilts must weigh between 150 - 300 lbs. (hogs will be weighed only once).

Rule 7 Livestock tie-outs, trucks, trailers, etc., must park in the **North Lot** or exhibitor will forfeit premiums.

Rule 8 Due to the high cost of postage, all premium checks are to be picked up in the Secretary's Office before the exhibitor leaves the fairgrounds. A social security number is required for the release of checks. If the check is not picked up, the exhibitor will forfeit their premium check to the Fair Association. If you would like your check mailed to you, please bring a self-addressed stamped envelope to the Secretary's Office (or purchase in the office) by 8 p.m. the last day of fair.

Rule 9 Ownership of animals must be at least 60 days!

Rule 10 Purebred gilts will be showed by age.

It is the responsibility of the exhibitor to clean stalls before leaving the fairgrounds.
