

Henry County Fair ABGA Sanctioned Boer Goat Show

Please note: The Henry County Fair has grown to become a very large Boer goat show. It is important that entry forms be filled out accurately, entries be received on time, and substitutions be kept to a minimum in order for accurate results to be recorded for ABGA points. Please contact the superintendent if you have any questions, and we will be happy to help you.

Check in: Sunday show: No earlier than 12:00 noon Saturday, June 29, 2019. No later than 7:00 a.m. Sunday, June 30, 2019. Exhibitors must be checked in with the superintendent immediately upon arrival. Notify superintendent of special needs on entry form. Market goat weigh-in 7:00 – 9:00 Saturday evening, 7:00 - 7:30 Sunday morning.

Show Entries: Use the Boer Goat Entry Form. Do not use the general livestock entry form. Entries must be filled out completely and postmarked on or before Monday, June 17, 2019. Does may be shown in market wether show but cannot be shown in both market and breeding class. Please put entries for shows 1 & 2 on separate sheet. This will be an Illinois Buckle Series Shows.

Wether show will take place at the conclusion of Show 1. Weigh-in 8:00am – 9:30am Sunday, June 30, 2019. Junior Market does may be shown in the wether class. This is an Illinois Buckle Series Show.

Entry fees:

Open jackpot classes: \$8.00 per entry. This includes a \$6.00 per head entry fee and \$2 per head pen fee.
 No entry fee for youth showmanship.

Exhibitor pass: \$15.00 (required for each exhibitor) Each separate owner is required to fill out a separate entry form and purchase an exhibitor pass. No refund on entry fees.

Health Requirements: A Scrapie Flock ID (Previously the Scrapie Premise ID) is required for all goat owners. In Illinois, call (217) 241-6689. Other states call your respective state veterinarian's office. A National Animal Identification System (NAIS) Premise ID can be acquired by contacting USDA, APHIS. This is a voluntary program.

All out-of-state **animals** require an **entry permit permits** available Monday through Friday 8:00 am to 4:30 pm at 217-782-4944. Market wethers and commercial does **MUST** have a SCRAPIE ID TAG in their ear.

All exhibitors must furnish official health certificates as required by Illinois state law. Upon arrival at the show, health certificates must be checked in with the superintendent immediately. Animals are subject to rejection from the fairgrounds for appearance of contagious disease at the discretion of the fair officials. This includes but is not limited to severe diarrhea, pinkeye, sore mouth, fungus in any stage, or abscess in any stage.

Rules and regulations:

All animals will be released after the show. Pens must be cleaned before leaving fairgrounds. Anyone not cleaning their pens will not receive premiums. Due to the high cost of postage, all premium checks are to be picked up in the secretary's office before the exhibitor leaves the fairgrounds. If the check is not picked up, the exhibitor will forfeit their premium check to the fair association. A social security number is required for the release of the check. If you would like your check mailed to you, please bring a self-addressed, stamped envelope to the fair secretary's office at check in. ABGA Rules shall govern.

All animals entered in the ABGA Sanctioned classes must be registered with the ABGA. Exhibitors must show original certificates of registration. No tattooing at the show. Animals with illegible tattoos or tattoos not matching their registration certificate will be excused.

No exhibitor may receive more than two monies in any one class.

When coming to the fair, enter at the northeast gate of the fairgrounds.

Market animals must show with their milk teeth. Goats with missing milk teeth or eruption of permanent teeth will be disqualified. Tags and tattoos must match weight card.

The Illinois Humane Care for Animals Act prohibits physical mistreatment of animals. Persons mistreating goats will be prohibited from exhibiting and/or lose their award.

THE SUPERINTENDENTS RESERVE THE RIGHT TO EXPEL PERSONS FROM THE SHOW FOR UNETHICAL OR UNSPORTSMAN-LIKE CONDUCT.
