Agreement and contract for leasing of merchant space and its operation from the Henry County Fair Association; Cambridge, Illinois.

I, _____ representing _____, hereby contract a legal and binding agreement with the Henry County Fair Assn. for the purpose of maintaining and operating a merchant booth on the Henry County Fairgrounds for the 2017 Henry County Fair. The Dates for the 2017 Fair are: Tuesday, June 20th through Sunday, June 25th.

In accordance with the rules of the Henry County Fair Association, I hereby submit a deposit of \$_____ as evidence of my intention to abide faithfully by this contract. Your deposit should equal 50% of your total charge. The deposit is due June 1st 2017. The Balance is due by June 20, 2017.

Camping space is available for \$25.00 / unit /day for electricity and water. The Camping space is a designated area on the "West Hill" of the grounds. Please fill out camping application form and send in as spots filled as properly completed applications are received.

Booths may be decorated within assigned space and to ceiling. Make no alterations to building or any fair property. Do not extend decorations/signs into aisle

The Building will be open during the days of the fair from 1pm until 9pm. We request that all booths be staffed during these hours. You must stay in the boundaries of your booth spaces. These booths will be divided by the Fair Association and marked with your name on the day of set-up. **You are responsible to provide your own tables, chairs, etc. With your booth space you will receive two exhibitor passes which will allow you admittance into the fairgrounds each day to be at your booth. You may purchase additional exhibitor passes at the cost of \$13.00/pass for any other staff that need to get in to help with your booth.**

GOLF CART PERMIT: \$25.00 per cart for week of fair. Must present proper insurance of cart.

NOTE: Set-up is MONDAY JUNE 19, 2017 from 10am until 5pm. Otherwise, you may set up on Tuesday when the building opens at 1pm. Thank you for your cooperation in making the 2017 Henry County Fair a great success.
