Rules and regulations: All animals will be released after the show. **PENS MUST BE CLEANED BEFORE LEAVING FAIRGROUNDS.** All premium checks are to be picked up in the secretary's office before the exhibitor leaves the fairgrounds. If the check is not picked up, the exhibitor will forfeit their premium check to the fair association. A social security number is required for the release of the check. If you would like your check mailed to you, please bring a self-addressed, stamped envelope to the fair secretary's office at check-in.

ABGA Rules shall govern. All animals entered in the ABGA Sanctioned classes must be registered with the ABGA. IMGA and ILWS rules shall apply to their respective shows. Exhibitors must show original or online certificates of registration and match tattoos. No tattooing at the show. Animals with illegible tattoos or tattoos not matching their registration certificate will be excused.

No exhibitor may receive more than two premium monies in any one class. When coming to the fair, enter at the northeast gate of the fairgrounds. Market animals must show with their milk teeth. Goats with missing milk teeth or eruption of permanent teeth will be disqualified. Tags and tattoos must match weight card. The Illinois Humane Care for Animals Act prohibits physical mistreatment of animals. Persons mistreating goats will be prohibited from exhibiting and/or lose their award.

THE SUPERINTENDENTS RESERVE THE RIGHT TO EXPEL PERSONS FROM THE SHOW FOR UNETHICAL OR UNSPORTSMAN-LIKE CONDUCT.

Market Goats shall be shown Slicked from hocks up ¼" or less. All others show haired. Memberships must be paid prior to the show to receive points for the IMGP buckle series or the ILWS.

Market animals and Commercial animals will show by weight in all shows!

Friday evening is ILWS points show.

ABA/JABGA shows will show concurrently on Saturday and Sunday.
